Electronic bids must be submitted to the office **Jaleshwar Municipality,Office of the Municipal Executive,Jaleshwar,Mahottari** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00Hrs** on **Monday ,18th jetha 2083,i.e 1st june 2026**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hrs on Monday ,18th jetha 2083,i.e 1st june 2026** at the office of **Jaleshwar Municipality,Office of the Municipal Executive,Jaleshwar,Mahottari** Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 60000/- , which shall be valid for 30 days beyond the validity period of the bid .
